# CHURCH OF THE ANNUNCIATION, SOUTH KENTON MINUTES OF ANNUAL PARISH COUNCIL MEETING (APCM) HELD ON 23<sup>rd</sup> April 2024

PRESENT: Revd. Trevor Goddard, Frances Saunders (Church Warden), Jacqui Goddard (PCC Secretary & Safeguarding Officer), Gwyn Evans (Stewardship Secretary), Patricia O'Reilly, & Tania Ruthven (Hall Manager) and parishioners.

**PREVIOUS MINUTES**: The minutes for the APCM meeting held on the 23<sup>rd</sup> May 2023 were ratified by the PCC on the 7<sup>th of</sup> September 2023 as an accurate record of the events of the last APCM as above.

#### **ELECTION/RE-ELECTION OF CHURCH WARDENS:**

The first item of business was for the Church Wardens to be elected/reelected. Sadly, Ben Skeete who had been a longstanding Church Warden, had passed away on 20<sup>th</sup> February 2024 and Frances Saunders had completed her term as Church Warden this year. Thanks were recorded for their contribution to the life of the church in this role.

Janet Spence was willing to stand as Church Warden. The meeting was unanimous in its agreement with the election of this post. There is currently one vacancy for the post of Church Warden.

Janet will officially be signed in as Church Warden with the Archdeacon on Tuesday 18th June 2024, 7:00pm at St Gabriel's, Cricklewood.

**REPORT ON THE ELECTORAL ROLL:** The 2023 – 2024 roll has changed from **44** to **42** people, with 3 people having been added, and 5 people having been removed - 3 people removed who are no longer living in the parish and not having attended for over a year, and 2 people having sadly passed away since the last APCM.

The new electoral roll was seen by all at the meeting and approved by and accepted by all present as an accurate record.

**REPORTS:** All reports were provided and highlighted as being within the main body of the annual report. To keep the meeting in a timely fashion only the finance report was read out and everyone was encouraged to take the time to read the other reports through in their own time.

#### PCC MEMBERS & DEANERY SYNOD REPRESENTATIVE (DSR):

As the PCC and the DSR are elected on a three-year cycle, there was no need for an election this year. Janet Spence continues in her role as DSR. Both roles enable her to continue to be an ex-officio member of the PCC. Both the PCC membership and the DSR role will be up for election once more in 2026.

**FINANCIAL REPORT:** The financial report was presented by Revd. Trevor Goddard as Eileen Heenan the Church treasurer was not available to attend the APCM. The report to the APCM was presented in line with the financial report provided. (financial report see page 16)

Trevor shared that the church's finances had done well to have a surplus at the end of the year, having completed the hall works and other key items of expenditure during the year. It was encouraging that we are continuing to be able to invest in and do new things while maintaining a good income and therefore a good balance sheet.

The accounts are currently being independently examined by Fr David Green. As the accounts for the 31 December 2023, had not been independently examined Trevor proposed that the approval of the fully examined accounts should be deferred until the next PCC meeting for the PCC to approve. This was agreed by the meeting. Once this has happened a copy of the independently examined the accounts will be made available on the website.

#### APPOINTMENT OF THE INDEPENDENT EXAMINER OF THE

**ACCOUNTS:** Rev Trevor proposed that Fr David Green FCA (Gowers LTD chartered accountants) be appointed as the independent examiner of the accounts for 2024. All agreed.

#### **VICAR'S REVIEW:**

Rev Trevor shared his vicar's report.

#### **ANY OTHER BUSINESS:**

Frances Saunders wanted thanks recorded to Trevor and Jacqui for all the work they do for the church.

There was no other business and Rev Trevor closed the meeting with prayer.

#### **POST PCC MEETING:**

The PCC met briefly after the APCM.

Present: Jacqui Goddard, Gwyn Evans (Stewardship secretary), Tania Ruthven (Eco Champion), Frances Saunders.

Apologies: Janet Spence (Church Warden) and Eileen Heenan (Treasurer) and Patricia O'Reilly.

Appointment of a Secretary: It was unanimously agreed that Jacqui should continue as PCC secretary.

Appointment of a Treasurer: Eileen has agreed to stand again as treasurer as of this APCM. All agreed.

Appointment of Safeguarding Officer: it was proposed that Jacqui be reelected as safeguarding officer all agreed.

Janet Spence has agreed to continue in the role as Children's Champion.

# **PCC** secretary's report

The most recent Annual Parochial Church Meeting (APCM) was held on 30th April 2024. This meeting was held on zoom. Since the last APCM there have been six meetings of the Parochial Church Council (PCC), each chaired by the vicar, the Rev Trevor Goddard. All have taken place via zoom.

**The church Electoral Roll**: As of April 2025, there are currently 44 names on the Electoral Roll.

3 names have been removed due to no longer living in the parish and not having attended regularly for a year or more.

5 names have been added.

#### **Church Governance**

The PCC members are appointed in line with the Church Representation Rules. The current PCC members were elected at the 2023 APCM for a three-year term until 2026, when the next election will take place.

The PCC is made up of the Vicar as chair, two church wardens (and up to two deputy wardens) and a Deanery Synod Representative – all of whom are ex-officio members and do not need to be voted on. In addition, there are members elected by the congregation who are on the electoral roll of the church. Where there are no more than 50 on the electoral roll of the parish\*, as is currently the case, then up to 6 lay parishioners can be voted onto the PCC. Our current numbers mean that at our next opportunity to vote in a new PCC in 2026.

\*Where there are over 50 but under 100 people on the electoral roll, up to 9 parishioners, on the electoral roll, can be voted onto the PCC.

The PCC members are responsible for making decisions on all matters of general concern and importance to the life of the parish church and community, in looking after the site buildings responsibly and including deciding how the funds of the PCC are to be spent.

As a PCC we have continued to stay focused around the practical care of the church buildings and church finance, ensuring that maintenance is prioritised and that we are planning to ensure the buildings remain fit for purpose. We have continued to work towards ways of becoming more eco-friendly in our care of the site and in the way we plan any events and activities.

# **Community reports**

#### Communication

Good communication has been supportive of growing our community and helping us to be in helpful contact with each other as a church family, as well as supporting continuing links with the wider neighbourhood. Physically, a new noticeboard at the front of site is clear, emphasising the key activities happening each week along with a QR code to have instant access to the church website. There are plans to replace the wooden noticeboard in the coming year with one that will not only advertise weekly events but also provide helpful information about the local environment form an ECO perspective.

Our website: southkentonchurch.org is a key way people find out about the church and has been an effective access point for those seeking out a place of worship, and especially at seasonal times of the year.

Our Facebook page: The Annunciation @ South Kenton again provides a simple access point for those using facebook, providing a much-needed communication and connection if attendance can't be so regular.

Our WhatsApp groups: whole church chat Prayer requests are enabling people to feel connected and grow a sense of belonging – that individuals have a voice in the community. They are actively providing friendship, encouragement, an up-to-the-minute noticeboard and memory jogger and a space to share prayer needs and requests.

We continue to be mindful of those who don't access the church through the multi-media platforms, that they can continue to feel as much a part of the church family as those that do.

# Worship life

Sundays are a mixture of modern and traditional, as we use familiar liturgy as part of our weekly communion service wrapped in a more modern flavour of sung worship. The CCL license is renewed each year so that we can legally reproduce lyrics on song sheets or on the big screen.

We have been able to share worship on occasion with our sister church, St Cuthbert's, especially when we share the worship during major festival seasons like Christmas and Easter – for instance, Midnight Mass at The Annunciation and Christmas day at St Cuthbert's for both churches, or sharing in the Churches Together walk of witness on Good Friday, followed by hot cross buns at St Cuthbert's before sharing the last hour of meditation and reflection for both at The Annunciation.

During the Advent season we brought our two churches (and neighbours) together once more with our community choir. We had 35 members join in for the carol services at both churches. This year we were so blessed to have Bishop Lusa join us for both events and bring his own unique style of sharing good news that inspired all who came, not least of all by starting out with a solo!







Our worship space allows for a more intimate experience of worship and prayer, which is valued on these occasions by both congregations.

# **Safeguarding**

Jacqui Goddard continues to hold the role of Safeguarding Officer (SO) for the Church of The Annunciation. Jacqui will stand for election again under the new PCC for 2025-26 as the role runs from just after the APCM until the following year at the same time.

She holds a Disclosure and Barring Service (DBS) certificate in her roles as PCC church secretary, Safeguarding Officer and Junior church leader. Jacqui is also a certified Evidence Checker for the Church, which means that anyone wishing to take up a role within the church and needs to be DBS (Disclosure and Barring Service) checked, will have their evidence checked by her through an online process. She is also able to support other local churches as an evidence checker in order for them to process their DBS certificates.

Safeguarding is a regular item on the agenda at every PCC meeting, to ensure that the safeguarding of children and vulnerable adults is kept in the forefront of our minds. Jacqui shares any updates from the diocesan safeguarding team at each meeting, as needed. The PCC have had the opportunity to attend online refresher safeguarding training during the year. All PCC members have completed a DBS check, as it is now required for those in leadership roles within the church to hold a DBS certificate. These will need renewing after 3 years.

This year the website safeguarding page has been updated, including items around recruitment. It is full of useful information, and everyone is encouraged to visit the website and find out more.

Janet Spence continues to hold the role of Children's Champion – again renewed directly after each APCM – a role the Church of England has created to ensure that the nurturing and practical needs of our children is always considered when any changes are made, or to be flagged if there is a gap in the way we provide for them as a worshipping community, when they are within our care.

#### **Eco church**



Meet our ECO Church & Creation Care Champion, Tania Ruthven. She is a member of our PCC and helps us to keep on our toes when it comes to being reflective in the way we use and care for our resources as a church community.

During the year we have made sure that 'ECO Church' is an agenda item each time we have met

as a PCC. With Tania's support we have made plans to improve our recycling, to think about how we can improve our site to become more 'eco-friendly' and think about how we can be a model of positive action, in our local community, of creation care. This includes things like installing bird boxes, creating rewilded areas in the grounds to encourage and support the wildlife, a retention 'basin' – a gentle dip in the land near to the church that collects and makes use of the rainwater coming off the roof.

We have installed air source heat pumps as our main form of heating in the church hall, acknowledged as a far more environmentally effective source of heating and have fitted double glazed windows to retain heat more efficiently. We are also making plans to insulate the walls and the ceiling/roof of the hall. In the church we have replaced the ceiling and ensured we have included insulation. We are making plans to replace the windows and frames in the church with double glazed windows in the spring of 2025.

#### Social and shared events

Throughout the year we have our monthly coffee morning, which has been a lovely opportunity for not only reaching out to our neighbourhood but of spending time together getting stuck into creative fun, for instance, recycling used calendars into greetings cards in the new year.







We enjoyed a lovely and surprisingly warm harvest lunch round at the vicarage at the end of September...

...before our Harvest Festival in the church hall, while the church was still being refurbished.





We have also enjoyed shared fun get togethers as both churches, at the vicarage as PCCs and for social or church events, like our shared lunch, our pancake evening and joining together to experience the annual Advent service at St Paul's.









In June it was a joy to share in the occasion of Winnie Kuta-Dankwa, our curate's priesting at St Gabriel's Cricklewood. We are blessed to have her serving with Trevor fully in her capacity as an ordained priest.

# **The Met Christmas Tree Appeal 2024**

It was great that we were able to support the Met Christmas Tree Appeal again this year. Although they are focussing mainly on fund raising now, Marianna Dominguez worked with the team from the Met to ensure that we could parcel up a huge number of Christmas presents for children across our local boroughs who were not going to be receiving Christmas gifts otherwise. Another successful year of bringing joy to the children in our neighbourhoods. Thank you everyone.



#### **Rotas**

As always, we're very thankful for everyone who signs up to be on a rota to serve everyone in church, week by week. We have been blessed by good numbers for the coffee rota, such an important part of our welcome as a church each week, spending time growing

together over a cuppa after worshipping together. We have also been blessed to add people to our prayer and reading rotas. These are such important ministries in our worshipping lives together.

# **Churches together**

This takes the form of five churches creating a joint event - The silent walk of witness and open-air service - Good Friday of Holy Week each year. Planning meetings are held throughout the year in preparation for the event. It is so encouraging to see churches coming together year on year to be part of a joint face of the Christian Faith in our local community. People carry crosses and walk silently, starting off at St Erconwald's church, up and down Preston Road before congregating on the green outside of The Preston pub for a short service of worship. This year's event had an improved sound system and worship led with a



singing guitarist and was a blessed occasion of united shared fellowship for all to see.

# **Scouts Christingle Service**

It was such a thrill to have the Scouts groups, who now meet in our hall twice a week – Squirrels, Beavers, Cubs and Scouts – ask us to host a Christingle service for them. Such a happy event and, for many of the children, the first time they would have set foot in a church. Including parents and scout leaders, over 100 people attended. They took part by doing a reading, by singing, enjoying Trevor telling them the Christmas story and what Christingle is all about, and saying their scouting promise together. Followed by refreshments in the hall. Such a happy event and one we hope will become an annual event in the church's Christmas calendar.







# A special 'thank you' to Jeremy...



It is with deep gratitude and warm affection that we say farewell – for now – to the Revd Jeremy Crossley. Jeremy has been an extraordinary presence in the life of The Annunciation over the past 13 years, faithfully supporting the parish by covering all my holidays, and offering me, spiritual counsel, wisdom, and friendship as my spiritual advisor. # **Church Warden's report**

This report gives a snapshot of business covered by the PCC during the year. We are thankful that, as a PCC, as well as maintaining all the services, activities and events that maintain and grow our faith together, we have been able to continue to resource the ongoing development of the site in growing a more welcoming and fit-for-purpose space for faith and community to grow. As a result, we are also beginning to see actual growth in numbers attending regularly.

#### Planned changes to the main worship area:

We are so glad that we've begun to take improvement plans forward during 2024 under our *church refurbishment project* - part of a more holistic view of the whole church site, which we will continue to take forward into 2025, when we will, in line with our ECO Church agenda, look at improving our lighting, use of the church building during the weekdays, installation of toilets within the main church and explore further how we can improve our grounds.

The church family and friends have been enjoying the benefits of a warmer and brighter, more welcoming worship space since the church ceiling was replaced and insulated, the majority of pews removed, and the space redecorated in the autumn. Visitors and church members alike have been thrilled at the difference it has made.









#### Hall lettings:

Hall lettings have continued to support the financial health of the church with long-term evening bookings on a yearly basis, Mondays to Sundays, with a wide range of activities taking place. The scout groups are continuing to go from strength to strength, meeting on Mondays and Fridays and join in with some of our coffee morning events, like the Christmas fair coffee morning. We supported them in turn by donating money raised from the raffle at the fair to them. Trevor is invited to attend some of their official events, like the swearing in of scouts and scout leaders. As already mentioned, it is so encouraging to be building connections and to have been able to support them with providing a Christingle service in the church during Advent.

#### Stewardship:

As Stewardship Secretary, Gwyn has continued to support the church in claiming back Gift Aid from the diocese, which we are very thankful for and, which provides a significant boost to our available funds. We are thankful for his ongoing support in completing this important overseeing of church giving and the time he continues to give.

We are thankful that the combination of regular giving, maintaining attendance and being able to continue with our services and activities, has allowed us to enjoy times of encouragement and blessing throughout the year as we continue to shine the light of God's love and the good news of his kingdom in our parish and beyond.

# The Vicar's Report for the Church of The Annunciation APCM 2025

# **Treasurer's Report for the 2024 Accounts**

To be presented at the Annual Parochial Church Meeting (APCM) in 2025

#### Introduction

The accounts for The Annunciation for the year ending 31st December 2024 are presented here in draft form. These will be reviewed and approved by the PCC following independent examination by Fr David Green FCA, who has once again kindly agreed to act as our Independent Examiner. This will be the last year that Ft David Green will be examining our accounts as he will be retiring so we are looking for a new examiner for 2025.

Our finance team in 2024 were Eileen Heenan (Treasurer), Janer Spence (Churchwarden), Gwyn Evans (Stewardship Secretary), Fr David Green FCA (Independent Examiner), and Rev Trevor Goddard (Vicar).

#### 1. Overview of Church Finances

The total assets held by the church as at 31st December 2024 stood at £191,669.57, down from £210,464.39 in 2023. This represents a net decrease of £18,794.82 over the year.

Despite a strong income stream, especially from hall rentals, the overall balance reflects a year of higher-than-usual capital expenditure—most notably, the £24,599.00 investment in the Church Refurbishment Project. Excluding this one-off cost, our core financial activities continue to reflect stable stewardship and ongoing generosity from our church community.

#### 2. Hall Accounts

#### Income

Hall income for 2024 remained strong at £27,589.66, almost matching the previous year's total. The hall continues to be a vital resource, both as a ministry venue and as a source of income for the church.

#### Expenditure

Hall-related costs rose this year due to increased maintenance and service expenses, including:

- Repairs and Maintenance: £4494.77

- Cleaning and Waste Collection: £4,024.35

Utilities: £6,906.24Insurance: £1,215.23

Total hall-related expenses amounted to £16,640.59. While this is higher than in 2023, these outlays reflect continued investment in keeping the hall in excellent condition. (Expenditure increased compared to 2023 when excluding one off capital expenditure for the Church Hall project.)

#### 3. Church Income & Expenditure

#### Income

Total gross income for 2024 (excluding transfers between accounts) was £31,355.17 including:

- Stewardship Giving: £7,426.52

- Collections from Services: £3,128.09

- Net Surplus/ Deficit from Hall account: £11,886.04

- Donations: £730.04

- Interest & Dividends: £7,836.92

- Sundry income: £347.56

The church did not receive Gift Aid payments or fee income in 2024, and Gift Aid claims are expected to be processed in 2025.

#### Expenditure

Total expenditure for the year was £50,149.99 including:

- Common Fund Contribution: £17,090.00

- Church Refurbishment Project: £24,599.00

- Church Expenses: £3,126.02

- Utilities and Insurance: £1614.65 (Church only)

- Cleaning & Maintenance: £1,718.00

- Vicarage and Church ministry Expenses: £1,852.08

- Sundry Expenses: £150.24

#### Overview

When we exclude the one-off refurbishment cost, our adjusted net expenditure is approximately £25,550.99, in line with previous years. However, the inclusion of major capital expenditure accounts for the

£18,794.82 overall deficit shown this year. Importantly, our unrestricted funds remain strong, and the investment in refurbishing the church will support our ministry and mission in the years to come.

#### 4. Balance Sheet Summary

As of 31st December 2024, the church's total assets stood at £191,669.57, down from £210,464.39 the previous year. This reflects the £18,794.82 net movement in funds.

Balances held in church accounts:

- Current Account: £7,157.73

- Business Premium Account: £42,493.50

- CBF Investment Fund: £142,018.34

These balances place the church on a secure financial footing as we look forward to 2025.

#### 5. Church Examiner

Fr David Green FCA who has examined the accounts of The Annunciation for several years has retired but has agreed to examine our accounts for 2024. Ft David Green has been a huge support over the years in scrutinizing our records and ensuring the information we present each year is accurate and concise. We thank Ft David Green for all his help and support over the years. We pray for him to have a happy and long retirement.

We will therefore need a new examiner for 2025. We do not have someone who has agreed to examine our accounts yet for 2025. I'm therefore propose that this meeting agrees we defer appointing an examiner for the Accounts and ask the PCC to appoint the new examiner as soon as possible. The next PCC meeting is on the 16<sup>th</sup> of July 2025.
